#### **GENERAL RULES**

Every class offered herein which is covered by the rules and specifications of the current federation rulle book will be conducted and judged in accordance therewith.

#### **FEDERATION ENTRY AGREEMENT**

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the Ledges Winter Series. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensa-tion, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

**ENTRIES** - Entries close 10 days before the start of each show. Entries postmarked later than 10 days before the show will be charged late fees. Horse show entries limited to the first 250 horses. Entries must be properly made on the official Entry Form with all blanks filled in where applicable. The following must accompany the entry form: 1) All stall fees are non-refundable after entries close! 2) Nomination fees for all classes. 3) Post entries will be accepted after the closing date of entries at the cost of \$30.00 per entry. 4) Checks made payable to: "Sporting Horses". MAIL ENTRIES TO: Sporting Horses, PO Box 290, Gilberts, IL 60136

Every entry shall constitute an agreement that the person making it, owner, lessee, trainer, agent, manager, coach, rider, and the horse shall be subject to the constitution and rules and regulations of USEF and the Ledges Winter Series

#### **MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation,

10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes..

**LATE / INCOMPLETE ENTRIES** - There will be a charge of \$30 per horse on all entries postmarked after closing date of entries or that are received at any time but are incomplete.

**CLASS ENTRIES** - Classes may only be entered by using the official class number, whether on the entry blank or on the Official Add/Scratch Form. The writing of a division name or class name will not constitute an entered class.

**CLASS DECLARATIONS** - Any class number written on the entry blank constitutes a declaration.

**NON-SHOWING HORSE** - A horse may be entered as "NON-SHOWING" on the original entry form at the time the entry blank is submitted by writing "Non-Showing" in the area of the entry blank where classes would normally be entered. An Official "Non-Showing Horse" is required to pay the stall fee and a \$100.00 Non-Showing Fee in addition to the Office Fee. Any "Non-Showing Horse" who ultimately enters classes and competes, is considered a post entry.

**EQUITATION ENTRIES** - Equitation Riders MUST ride the horse and wear the number of the horse they are officially entered on. If the rider desires to change horses for an equitation class, he may do so without penalty; however, he must do the proper paperwork in the Horse Show Office on the Official Form, i.e., scratch the equitation class on the one horse and add the same equitation class on the new horse. Exhibitors who enter an equitation class on one horse and ride or wear another horse's number will be charged on both horses. You MUST do your paperwork in the Show Office in order to avoid this penalty.

**ENTRY/CROSS ENTRY** - Exhibitors are responsible for a knowledge of the Rules and Regulations governing the horse show and for their own errors and omissions. In the case of a violation of a cross entry restriction, the exhibitor will forfeit the entry fee, class placing and prize money award.

**ENTERED AND DID NOT COMPETE** - Any exhibitor who does not compete in class/classes in which the exhibitor is officially entered, and does not scratch according to the Scratch Procedures outlined above, will be billed for the class/classes. You MUST do your paperwork in the Show Office in order to avoid this penalty.

**NOT ENTERED AND DID COMPETE** - Horses shown in a class without being officially entered will pay double the class fee. You MUST do your paperwork in the Show Office in order to avoid this penalty.

CHANGES PRIOR TO NUMBER ISSUE - An exhibitor is allowed to make class changes in the Horse Show Office to an entry without penalty at the time the exhibitor's entry number is issued. This is a one-time-per-show only grace period, giving the exhibitor an opportunity to make adjustments to the original entry prior to picking up numbers. Once the exhibitor number has been issued, the normal rules and fees to add and scratch classes will prevail. (The grace period applies only to class adds and class scratches of "showing" horses and does not affect rules regarding stall fees, jumper nomination fees, post entry fees, show scratches, etc.)

**ADDS** - Class adds may only be made in the Horse Show Office on the Official Form, by letter or by Facsimile and must be received prior to the start of the class. Any other method WILL NOT be considered valid. For scheduling

purposes class adds must be declared by 5pm on the previous day. Upon arrival at the show please check the status of day adds in the office. If entries warrant, same day adds may not be allowed.

**SCRATCHES** - Scratches may only be made in the Horse Show Office on the Official Form, by letter or by Facsimile and must be received prior to the start of the first class entered in. Any other method WILL NOT be considered valid. Once a class begins, it

may not be scratched, except for a Vet Scratch. If a Vet Scratch, the horse must be scratched on the same day of the class/classes scratched in the Horse Show Office on the Official Form and the Official Vet's Certificate must be received in the Show Office by close of business that day.

SHOW SCRATCH - A horse that is scratched from a show prior to the start of the first class entered in, will forfeit a \$50.00 office

CLASS SCRATCH - A fee of \$5.00 per class will be charged for classes scratched.

**SUBSTITUTIONS** - Under the same ownership, a new horse may be substituted for a scratched horse. If the scratched horse is not stabled at the show, the substitute horse may assume the commitment and payment for the scratched horse's stall and the scratched horse will be responsible for only the \$50 office fee.

**REFUNDS** - Refund of all pre-paid fees may be given for show scratches received or postmarked prior to or on the closing date of entries. After the closing date of entries, stall fees, horse deposit fees, Jumper nomination fees and RV fees are NOT refundable under any circumstances.

Once a horse is nominated, the nominating fee is not refundable, even though the horse may not ultimately compete in classes requiring a jumper nomination. Nominated jumpers are eligible for a 50% refund of the Jumper nomination fee if the horse is a show scratch and is scratched prior to the start of the horse show at the time numbers are picked up in the Show Office.

After the closing date of entries, only pre-paid entry fees are eligible for refund. Class nomination fees, intent fees and post entry fees are not refundable after the closing date of entries. If eligible for a refund, a check for the amount of refund due less an office fee of \$50 will be mailed within 30 days after the completion of the Ledges Winter Classic Requests for refunds after the conclusion of the Ledges Winter Classic will not be considered. The policy herein with regard to scratch fees will be followed regardless of weather.

COGGINS - Effective January 1, 1995 - All Illinois Equine (horses, ponies, mules, etc.) 12 months old and older participating in an advertised equine event ("Advertised equine events" means a show, rodeo, exhibition, trail ride or horse fair, excluding sales or auctions, that is posted or media promoted") must be accompanied by a negative test for equine infectious anemia/E.I.A. (Coggins/CELISA) conducted within the previous 12 months. A health certificate IS NOT REQUIRED FOR ILLINOIS EQUINE.

**HEALTH PERMITS** - The Illinois Department of Agriculture now requires permits for all horses traveling to competitions in Illinois from out of state. Permits can be obtained by calling the Illinois Department of Agriculture's Bureau of Animal Health at (217) 782-4944. The phone line is staffed 24 hours a day, seven days a week. Electronic permits also will be issued through the department's website at www.agr.state.il.us.

**DAY EXHIBITORS** - Day Exhibitors will not be permitted without prior written approval of management.

RINGS AND FOOTING - The indoor arena at Ledges is 100' x 200', the warm up ring is 84'x100' with a limestone base and sand footing.

NON-NEGOTIABLE CHECKS - Checks returned by the bank for any reason will be assessed a penalty of \$50 or 10% of the face amount of the check, whichever is greater. Upon notification of a returned check, accounts will be given three days to make full payment, including the penalty, which must be paid in certified funds, cashier's check or money order. Overnight mail service is advised in order to avoid notification of the sanctioning organizations for disciplinary action. Exhibitors are hereby forewarned that first time returned checks will be reprocessed automatically.

PRIZE MONEY - Prize money will be available by check in the Horse Show office or premiums can be subtracted from your payment due. Once a reward has been made, the responsibility of the horse show shall cease. This horse show offers \$29,750.00 hunter prize money and guarantees a minimum hunter prize money payout of \$5,000. 2023 Prize money Pay outs: 313728- \$11,465.00, 6258-\$5,000, 1962, \$7400.00, 1376-\$12,160 **MEASUREMENTS** - Fridays at 2 pm

**JUMP ORDER** - A rotating jump order will be established for all classes over fences and such shall be posted by the in-gate. Courses will be posted at the in-gate. The management reserves the right to the use of a dotted-line in any hunter and equitation

**CHAMPION AND RESERVE CHAMPION** - To be awarded to two of the four horses scoring the most points over fences. In addition, only these will receive full points for ribbons won under saddle and half points for ribbons won in the model.

**SCHOOLING** - There will be open schooling up to 1-hour prior to start time.

VETERINARIAN - Janesville Equine Hospital and SURGICAL CLINIC. 5021 N. State Rd. 26, Janesville, WI 53546. Emergency #(608) 868-1765 - Travel Directions: Located on Hwy 26 between Janesville and Milton. From South/East: Take I-90 West. Take the Janesville/Milton exit 171A. Merge onto Highway 26. The clinic is approximately 1 mile ahead on the left. From the North/West: Take I-90 East. Take Exit 171A-B for Hway 14/26. Turn left at the stop sign at end of ramp. The clinic is approximately 1 mile ahead on the left.

**DISPUTES** - Should any questions or disputes arise that are not provided for in the foregoing rules, the same shall be referred to the show committee, whose decision shall be final.

PROTESTS - Protests shall be governed by USEF Rule GR603, upon the deposit of the appropriate fee of \$200.00 members / \$300 nonmembers.

DISCLAIMER - Neither the Ledges Winter Series, nor Ledges Showgrounds LLC, nor Showplace Productions, nor the Show Committee will be responsible in any way for loss or damage to any persons, animals or property or equipment that may be caused by any horse or pony entered by him or due to the carelessness or negligence of the person or persons in charge of such horse or pony or of their subordinates. THIS SHALL BE A CONDITION OF ENTRY TO THIS HORSE SHOW OR SHOW GROUNDS.DAMAGE - All owners and exhibitors shall be held responsible for any damage incurred by them, their agents or employees to stalls, buildings and other properties on the show grounds, and shall be billed accordingly.

#### SHOWPLACE PRODUCTIONS' GENERAL AND ANIMAL WELFARE POLICY FOR RIDER, TRAIN-

ER. OWNER. AND GROOM - Upholding the welfare of the horses exhibited here is of primary concern to Showplace Productions. We require that all horses be treated with kindness, respect and compassion and never be subject to mistreatment. Owners, trainers, riders and grooms, or their agents, must use reasonable care in handling and treatment of their horses, whether owned or placed in their care for competition or for any other purpose. At all times while the horse is on the show grounds we will provide for the continuous well being of the horse by vigorously enforcing the rules of the USEF which pertain to the welfare of the horse. Exhibitors are cautioned that GR302 (which defines the USEF's policy on abuse), GR806 (which pertains to Poling), and GR320 (Which pertains to the Use of Whips), will be strictly

enforced. Any handling and veterinary treatment should ensure the health and welfare of the horse. High standards of nutrition, health, sanitation and safety shall be encouraged and maintained at all times. Adequate provision will be made for ventilation, feeding and watering and maintaining a healthy

environment.

Any method of riding and training should take account of the horse as a living entity and must not include any technique considered to be abusive. The well being of the horse must be considered above the demands of the breeders, trainers, riders, owners, dealers, organizers, sponsors or officials. Violators are subject, under the above rules, to elimination from competition and to protest or charge with resulting formal proceedings which may result in severe fines, suspensions or other penalties.

To affirm the sport of show jumping to the general public in a positive, humane light and eliminate those training, methods which may be misconstrued, we are maintaining the following policy in all areas of the horse show grounds, starting one half hour before the first scheduled class of the horse show and continuing

until the last scheduled class of the horse show is completed. **POLING AND OFFSETS** - Manual poling and or the use of bamboo pole offsets are prohibited. Any rider or trainer found poling or using offsets, as well as the horse or pony involved, will be immediately eliminated from the class where the incident occurred, be suspended for a twenty four hour period starting from the time of the incident and will forfeit all entry fees. In the case of further violations by that exhibitor, on the same horse or another horse, the exhibitor may be barred from any or all future classes at the show and all stabling, nomination and entry fees will be forfeited.

**USE OF WHIPS AND SPURS** - Any rider, who in the opinion of the judges, stewards or schooling supervisors, uses their whips or spurs in a cruel or excessive manner will be immediately eliminated from the class in which the incident occurred, may be suspended from further showing for a twenty four hour period starting from the time of the incident. In the case of further violations by that exhibitor, on the same horse or another horse, the exhibitor may be barred from any or all future classes at the show in which the violations occurred and all stabling fees, nomination fees and entry fees will be forfeited. All incidents will be reported in the Steward's and/or Technical Delegate's Report and reviewed by USEF's Executive Director for possible further investigation and charges for hearing before USEF's National Hearing Committee.

**MEDICAL WASTE** - Sharps must be placed in the proper receptacles. Anyone found in violation shall be subject to a fine or other penalties deemed necessary by Horse Show Management.

PROTECTIVE HEADGEAR - (Excerpt from USEF Rule GR801)It is compulsory for all persons at Federation licensed hunter, jumper, or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear in compliance with the accepted testing standards published on the Federation's website. Protective headgear must carry the applicable quality testing tag and/or label. It must be properly fitted with harness secured. Exception: In Hunter or Jumper classes, adults may be allowed to remove their headgear while accepting prizes and during the playing of the National Anthem only; they must refasten their headgear prior to the lap of honor. It is compulsory for riders in Paso Fino classes, both open and breed restricted including Hunter Hack, where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear. It must be properly fitted with harness secured. A Show Committee, Competition Management, and Licensed Officials must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience.

**FEED AND BEDDING** - Feed and bedding orders will be taken through the show secretary. These orders must be taken by 1:00 p.m. each day! You must phone in early with your shaving needs. If you bring in your own shavings there will be a \$30 per stall clean out fee added to your bill.

**LEASH LAW** - Per USEF Rule 1301. Dogs are not permitted to be loose on competition grounds and must be on a leash or otherwise contained. Individuals must not lead dogs on a leash while mounted. Dog owners failing to comply with this rule may be subject to penalty under ch. 6 & 7, as well as issuance of warning cards.

PERSONAL ELECTRONIC TRANSPORT: Per USEF Rule 1301.8 The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas

MOTORIZED VEHICLES/GOLF CARTS - Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind. including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/ legal guardian or individual who signs the entry blank as a parent or quardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**TRAINER'S SPLITS** - The Ledges Winter Series offer a service that allows the trainer to purchase shavings, feed, tack stalls, etc. directly from the Horse Show and then split the total amount for some or all of these items and have it charged directly to their client's show bill. Any Horse Show Secretary can assist the trainer with this process. Trainer splits will be accepted until noon Friday (no exceptions) of each show week. Please advise your clients that these charges will appear on their show bill. Trainers are reminded that this is a service provided by the Horse Show and that doing splits in a timely manner is their responsibility. Additonally, any splits uncollected from the client will revert back to the trainer for payment.

**STABLING - STALLS** - All horses and ponies must have a stall. Stabling is limited to 250 horses in 10' x 10' permanent stalls with steel doors and a limestone base. Stalls are in permanent buildings. Stalls will be available at 7:00 A.M. on the preceding day of each horse show and fees are \$275.00 per stall. Tack stalls will be \$275.00 - and are limited. Please contact Nicole Boyle at 847-340-1742 or showplaceproductions@gmail.com for all your stabling and bedding needs. After reserving your stalls, you will be charged for all your no shows. Please call and confirm your stalls even though you are sending entries in.

**USHJA** - All horses competing in Federation non-breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes (except those activities enumerated in GR901.1, items 1-9) must be properly identified and must obtain a Registration Number from USHJA

SAFE SPORT POLICY: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

SHOW PASS FEE: Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors on-line only. Competitions should not accept payment for show pass fees and therefore this fee should not appear on the entry blank. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF-licensed competition.

#### MICRO CHIPPING

Beginning in the 2019 competition year, all horses competing in USEF-licensed and/or USHJA-sanctioned competitions with Hunter, Hunter Breeding, Jumper, and Hunter/Jumping Seat Equitation classes not restricted by breed will be required to be microchipped. This will be a requirement for all horses competing in these classes. USEF has provided education materials to competitors to learn more about microchipping and the rules (HU101, JP100, EQ103).

At competitions, exhibitors may ask to turn in a USEF Microchip Reporting Form. Please let them know they can report the microchip number directly to USEF three ways:

- 1. Online by signing into their My USEF My Way account and updating the horse's record.
- 2. Faxing to (859) 231-6662 or emailing to horseservices@usef.org the Microchip Reporting Form, which may be used to report chip numbers for multiple horses.
- 3. Completing the microchip field on a USEF Horse Recording/ ID Application. The completion and submission of this form is the sole responsibility of the competitor. Competition staff are not responsible for assisting with the forms. Our office will check the form to ensure accuracy and completeness once received.

**COURSES:** Courses may consist of any combination of the following: Brush, gates, oxers, posts and rails, water, Liverpool, walls, panels, and coops.

MARTINGALES: Classes offered at 1.30m or below have no martingale restrictions when used in a conventional manner. Classes offered above 1.30m (and all classes restricted to young horses) - the only martingales permitted are running martingales used in the conventional manner.






